### **Student Evaluations**

Student Evaluations: Spring, 1998 to Present

Student evaluations since Spring, 1998, utilize a different format. Question # 7 reads: "Give an overall rating for the class." Question #8 reads: "Give an overall rating of the instructor." In addition, the rating scale was changed: 1=Outstanding; 2=Good; 3=Fair; 4=Poor. This reverses the earlier rating system where a higher score indicated better evaluations.

The following classes have been evaluated with the new rating format. My scores for both questions are presented along with the department averages for all classes. The rank for question #8 is also included.
